OLD NEWS AND UNFINISHED BUSINESS

- The Fall year end Banquet at the beautiful Fairmont Hot Springs included:
- A general members meeting, dinner provided for the membership by TSCHA, Awards Presentation, comment box and two Hat Voucher giveaways and extra drawings.
- Our Silent Auctions (Spring & Fall) totaled \$2,017

APRIL 7 - 8 406 Arena, Vaughn

- Silly Campbell secured a Cattle Supplier Agreement with Lane Yeager

MAY 6 Blue Ribbon Pavilion, Deer Lodge

- Darrell Lee (MCHA board member) was present to represent MCHA in offering us an invitation to TSCHA to co-produce this show. MCHA wishes to open their door to our membership and encourage a positive working relationship between both organizations. Many of their members may enjoy our two-handed classes and our members can see if they might enjoy being part of the classes that MCHA offers as well.
- MCHA has already secured cattle that would include our classes as well.
- It will reduce/eliminate considerable costs, planning, and setup/takedown for TSCHA, therefore taking substantial risk out of holding a show at this new venue for the first time.
- Classes that MCHA/TSCHA share will be at the MCHA entry fees and payouts. Those classes would be: Open, Non-Pro, \$5,000 NH & \$5,000 NHNP, Youth and \$2,000 Limit Rider.
- All TSCHA/Cowhorse classes will be at the TSCHA rates and payouts (any NWAB class would be MCHA only)
- The TSCHA/Cowhorse classes will run following all combined MCHA/TSCHA classes for our Show Secretary to effectively keep the two Associations books organized.
- Darrell had discussed this extensively with Kelly Fraser, Show Secretary for both MCHA and TSCHA and she feels optimistic that we can do this and manage both associations books as usual.
- MCHA has again offered a free membership to any TSCHA member that has not been a member with them in the past year (2022). With the MCHA membership, an NCHA membership is also required. Currently, NCHA offers anyone who has not been a member in the previous (3) three years a free membership as well. Memberships may be completed online or paper form. Information will be provided to you prior to the show.
- TSCHA discussed reciprocating free memberships in kind to MCHA for those that have not been members with us in the past year and there was also much back-and-forth discussion about this. When we voted, all had agreed to extend the offer for this year.
- There was a lot of back-and-forth discussion by the board with many questions and concerns presented. The board decided to proceed with just a one-day, one-time show, to be evaluated and considered with our membership for any future co-produced shows. To confirm, at the end of our discussion and prior to the vote being taken, all board members decided to give this a try, this one time.
