### **VENUES:**

After much discussion it was generally agreed that three separate cutting shows in Deer Lodge would not be possible based on the limited availability of cattle. Later, a motion was made to run a combined show with MCHA and TSCHA on May 4 and look at holding an independent TSCHA show in deer Lodge possibly next year. For the combined show, all cattle will be run through MCHA, same as in 2023.

## \*WELLS FARGO ACCOUNT:

We have one outstanding check. Need to reach out to recipient and check if we need to reissue a check from new Stockman Checking. Jessica Lee as Past-President needs to close the Wells Fargo Accounts as she is currently signer on both savings and checking. Current balance in checking in savings for WF accounts is \$9,372. Will get a cashier's check upon closeout to deposit into Stockman savings.

<sup>\*</sup>Stockman Account holds \$22,918 in checking and savings.

<sup>\*</sup>We had a deficit of \$500 due to less attendees at the Year End Banquet. We made \$200 less than in 2022.

- \*Sponsorships for 2024: \$1,725 towards the Saddle Raffle. We need an additional \$1,275.00 for the Saddle Give Away this year.
- \*2023 we had less entries than in 2022. We need to work on more sponsorships and attendance. Try to keep a 5-7% profit margin from shows.
- \*Katie will add shows to our insurance policy once she has a schedule. She will stay on top of making any necessary changes. Producers of shows need to carry insurance for the practice day and are responsible to cover the \$45 coverage fee.
- \*We now have a new Venmo account / @TreasureStateCHA.
- \*Our Legal entity remains as TSCC. We are DBA(Doing Business as): TSCHA To change our Legal name to TSCHA, we would need to dissolve the entity and start all over, a lot of work to change an LLC filing with SOS(Secretary of State).

### **MISCELLANEOUS:**

\*Ken asked if our Mission Statement could be shortened, as it is too wordy. Sandy stated that there are requirements to maintain our non-profit status; therefore, our Mission Statement follows all the legal parameters and cannot be shortened. We are allowed to condense the content and post alongside the original statement. Sandy will work on a condensed version.
